
Please be advised that the entitlement for this Seminar from National and Sub-National Branches is as follows:-

Accommodation, ground transport and meals will be provided during the Seminar. Spouses and Accompanying Officials shall be responsible for their own accommodation.

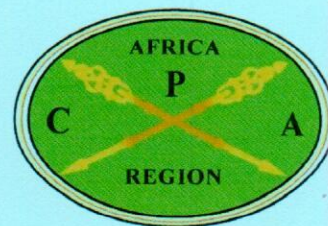
